What is Fluenz™ Tetra?

Fluenz Tetra is a nasal spray to help protect against influenza (flu).¹ It is used in children and adolescents 24 months to less than 18 years of age.¹

How does Fluenz Tetra help protect children?

When a person is given this flu vaccine, the immune system (the body's natural defence system) will produce its own protection against this influenza virus.¹

It's reassuring to know that none of the ingredients in this flu vaccine are likely to cause the flu.¹

This flu vaccine targets four strains of influenza, and complies with the strain recommendations made by the World Health Organization every year.^{1,2}

What are the possible side effects?

The flu vaccine for children has been well tolerated by most children, but some may experience side effects.¹

Serious side effects are very rare (may affect up to 1 in 1,000,000 people): severe allergic reaction – signs include shortness of breath and swelling of the face or tongue.¹

Other possible side effects:¹

- Very common side effects (may affect more than 1 in 10 people) are: runny or stuffy nose, reduced appetite, weakness and headache. These side effects are much less serious than developing flu or complications associated with flu.^{1,3}
- Common side effects (may affect up to 1 in 10 people): fever, muscle aches
- Uncommon (may affect up to 1 in 100 people): rash, nose bleed, allergic reactions
